Replacement of rear elevation ground floor fenestration and extension of rear patio into garden.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policies D1 and D2 of the adopted Camden Local Plan 2017.

3 The development hereby permitted shall be carried out in accordance with the following approved plans: SP01, 01, 02, 03, 04, 05, 06; Design & Access and Heritage Statement 370410 DA H01.

Reason: For the avoidance of doubt and in the interest of proper planning.
