OBJECTIVE-cut back all branches interfering with scaffolding + sheeting
-cut back 1x limb to 3m separation from scaffolding
-remove well-established ivy growth to ground level
-sever and poison main ivy source stumps
-reduce crown by 30%(3m)
-reduce sides to match(3.5max in places)
-remove all dead/diseased wood
-carry out full aerial inspection
On Church land:
T2-Robinia(R.pseudoacacia)
-cut back all overhanging branches to boundary line with 3m separation from scaffolding

G1-Row 7x Lime(Tilia)

- tree nearest scaffold cut back all branches to boundary line
- raise canopies to 3m above ground removing all epicormic growth
