This cavity is decaying back into the main stem, one of the main unions is showing visual signs of having split apart under mechanical loading. To reduce the mechanical loading on the union and the cavity, the suggested works are: to reduce the tree approx. 0.5m below the previous points to suitable growth points, remove deadwood.	£230.00
