Purple plum (T1) - Reduce crown back to previous cuts, removing all epicormic growth. The tree is pruned every 1-2 years to maintain the shape and size and allow light into the bottom flats.

Bay (T2) - Fell tree and cut stump to ground level.

Crab apple (T3) - Reduce crown back to previous cuts. Thin crown by 20%.

Cherry (T4) - Remove lowest branch over neighbouring garden, remove two garden side branches to maintain an even crown. Reduce crown by up to 1.5m on all aspects leaving a natural outline.
