Minor change to the of height and type of side window so that the window is slightly lower and is a traditional one over one sash window. The revised plans provide the detailed profiles. The rear elevation plans also have a minor change to the glazed doors which are a traditional crital type glazing pattern with more glazing bars and increased width of the doors. The rear elevation is not visable from the road and the change is consistent with the Camden Design guide which encourages a hierarchy of glazing so that the largest openings are at the ground floor. The choice of glazed doors conforms with policy in that it is a traditional design which is consistent with the age of the host building and has a neutral or positive impact on the conservation area.
