Details of brickwork required by condition 11(g) of planning permission 2015/3936/P dated 06/04/2016 (for development of the site to provide 156 residential units including works of demolition, basement excavation, new build, tree removal and associated works).

## Informative(s):

1 Condition 11(g), requires details of a 2mx2m brick panel, however the Pavilion buildings are built into the land and there will not be 2mx2m of brickwork. The applicant has therefore provided a sample of the curtain walling that will be used to the front elevation. The sample has been reviewed on site and is considered to be of a high quality and will safeguard the appearance of the development in



accordance with the objective of condition 11(g).

The site's planning history and relevant appeal decisions were taken into account when coming to this decision.

Special regard has been attached to the desirability of preserving the listed buildings or their setting or any features of special architectural or historic interest which it possesses. Considerable importance and weight has been attached to the harm and special attention has been paid to the desirability of preserving or enhancing the character or appearance of the conservation area, under s.66 (LB's) and s.72 (CA's) of the Listed Buildings and Conservation Areas Act 1990 as amended by the Enterprise and Regulatory Reform Act (ERR) 2013.

The details provided are in general accordance with policies CS14 of the London Borough of Camden Local Development Framework Core Strategy and policies DP24 and DP25 of the London Borough of Camden Local Development Framework Development Policies.

2 You are reminded that conditions 5-7, 8 c,e and g, 9 c,d,e,f,g and i, 10, 11 a-f, 12, 14, 19, 21, 23, 25, 27, 28, 30-32 and 34 of planning permission 2015/3936/P are outstanding and require details to be submitted and approved.

In dealing with the application, the Council has sought to work with the applicant in a positive and proactive way in accordance with paragraphs 186 and 187 of the National Planning Policy Framework.
