Purple Cherry Plum T2 (6M high/ 400mm dia.) - remove low limb over patio area. Reduce crown overall by up to 2metres and remove all epicormic growth within crown

Black Poplar T3 (22M high/ 1000mm dia.) - reduce back to previous points of reduction (4M). Remove all epicormic growth

Common Lime T4 (20M high/ 600mm dia.) - reduce back to previous points of reduction. Remove all epicormic and deadwood.

Wych Elms T4 & T5 (8M high/ 200 & 150mm dia.) - remove smallest tree. Remove low limb over rear of number 24 Belsize Crescent

1. To reduce excessive shading to frontage of Akenside Court and patio/communal area at rear
2. To enable improved natural light availability to Akenside Court and communal area to rear
3. To prevent potential breakout of large re-growth from previous pollarding of Black Poplar
