T239: Birch - Cut the entire tree to ground level This tree is dead

T426: Maple - Cut the entire tree to ground level This tree is dead

T530: Holly - Cut the entire tree to ground level This tree is dying

T544, T545 & T546: Hollies - Cut the entire trees to ground level These trees are 80% dead
