T1: Olive: Remove dead wood from lower crown.

T2-T5: Magnolia Grandiflora: Reduce lateral and sub lateral branches growing over garden back into main stem to form a flatter profile against the wall.

T6: Birch: Thin crown density throughout by 20%.

Rear Garden:

S1: Osmanthus: Light reduction.

S2: Bamboo: Remove dead stem whilst preserving screen.

G1: 3 x Olive: Poor condition. Remove group.

S3: Photinia: Remove climbing plants and remedial prune as required.

S4: Rhododendron: Reduce by 2.00m.

T7: Hazel: Reduce overhang by 20%.

7. Identification Of Tree(s) And Description Of Works

T8: Magnolis Grandiflora: Reduce by 20-25% to tidy.
T9: Birch Stump: Fell to ground level.
T10: Portuguese Laurel: Dead. Fell to ground level.
T11: Purple Plum: Reduce crown by 25%.
T12: Sycamore: Located in Oak Hill Park. Remove one low limb approximately 10cm in diameter to raise crown by 2.50m.
S5: Laurel: Raise crown by 1.00m. Trim overhang by 15-20%.
T13: Chestnut: Located in Oak Hill Park. Reduce overhanging limb by 30-40%.
T14: Bay: Raise crown by 1.50-2.00m.
S6: Laurel: Reduce overhang by 20%.
S7: Rhododendron: Reduce by 2.00m.
T15: Yew: Reduce overhang back from acer and lawn by approximately 1.50m. Reduce height by 25%.
