Our nursery garden is adjacent to the property and I am concerned on three points.</p> <ol style="list-style-type: none"> 1) I have not been approached or given access regarding a light test for our garden area. Our own observations reveal that our garden will lose total direct sunlight from all directions during the day. This is the only available outdoor play area for the children. 2) The ability for the children to access this area safely during the build. 3) I am concern how overlooked the our garden will be from the new windows. <p>The timing of this applications and the fact that I have not been contacted by any parties, means that we are closed for the holidays and will not be able to represent the nursery at the planning committee.</p> <p>I would like the opportunity to speak to the planning committee regarding this application.</p>

The nursery were not notified of the application and heard about it by chance, and as it is now the summer holidays they are not able to respond properly or attend the committee - hardly ideal or fair when they are a business immediately adjacent to the proposed work. But my main reason for objecting is for the longer term damage done to the nursery itself. York Rise Nursery is a fantastic nusery for local families - the only one of its kind - and is brilliantly run by Becca Coles. It is a very important part of the Dartmouth Park Community. There is not much outside space for the children to use, but they make the most of what they have with their small side area, which the children spend time in every day, weather permitting, for both group activities and free play, including growing plants. As a parent I would be concerned about this area being too over-looked and also for the light being removed from it, at which point it really would become a far less attractive space. This is not even to mention the noise, disruption and dust while the proposed work is underway. This nursery has been in operation for 25 years and I fear would be severely impacted by this work so I wish to object to this application in the strongest terms. At very least more time should be allowed for relevant tests to take place.</p>

And therefore wish to object to this proposal.</p> <p>The nursery manager has submitted evidence to you suggesting that to the best of their knowledge the garden will lose total direct sunlight from all directions. I am concerned that this will both impact on the amount the children play outside and hence potentially lower their levels of physical activity. Plus also impact on their vitamin d levels.</p> <p>You will be aware that activity is essential in helping to reduce obesity levels. Currently 1/5 children who start primary school is obese or overweight. Reducing obesity saves lives as obesity doubles the risk of dying prematurely. Physical activity in children is associated with numerous health benefits for children such as muscle and bone strength, health and fitness, improved quality of sleep and maintenance of a healthy weight (see DH's childhood obesity: a plan for action). Only 1 in ten children aged 2-4 (the age range of the nursery) meets the Chief Medical Officers physical activity guidelines for this group. So it is very important that nothing is done to reduce potential activity.</p> <p>Under section 2b 1 of the NHS Act 2006, which was inserted by the health and social care act 2012, every unitary and upper tier local authority in England is under a duty to take appropriate steps for improving the health of people in its area. Responsibility for children's public health was transferred to local authorities on 1 October 2015.</p> <p>I am concerned about the potential impact of this build on the public health of the children using the building and would ask the local authority to consider this carefully in the light of its statutory duties.</p> <p>Please notify me of the committee date.</p>

My children attend as do many local kids. The new extension would block all light into the nursery's garden and when completed would mean the garden is totally overlooked.</p> <p>Also, there is a safety issue concerning the children while the works are in progress. Presumably they would be unable to access the garden for the duration of the build which would be awful given that this is the only outdoor space available to them.</p> <p>The nursery use this garden every day even in winter so the kids can play outside. If the application is granted, then their entire daily routine would be disrupted.</p> <p>For these reasons the application should be refused.</p>
