We will also have a substantial retail portion of the business where we will be selling dental products such as toothbrushes, toothpastes, electrical toothbrushes and a variety of dental flosses. I strongly believe my dental practice will contribute to the diversity of services which Neal St and the 7 dials area provide. I also believe that allowing 61 Neal St to become a D1 use will not cause any harm to the amenity of the area and the residential population.
