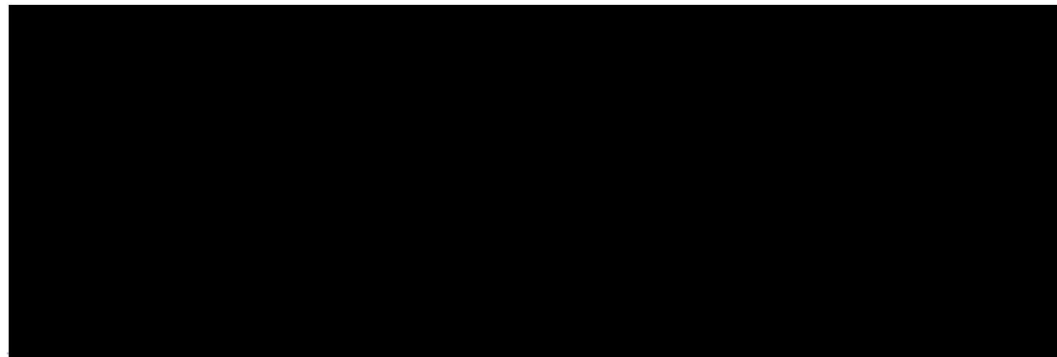
I have another tree issue, this time with an elderflower tree at the back of our garden which is part rotten and dying and so we would want to fell it and replace it with another tree.
