The tree was thinned lightly in December 2016, at the time some broken limbs that had fallen into the centre of the tree were removed, since the tree has come back into leaf 3 large branches have broken out over the garden with the tree and one of the next door properties. I believe this is partly due to the exceptional weather conditions that we have been experiencing, however neither the

owner of the tree nor his neighbours, who have young children feel they can use the end of the gardens for fear another limb will break out.

Reduce the crown by 30%, by approximately 3 metres over the crown, cut back limb extending over the gardens to the rear of the property so that it is within the crown of the tree and remove any dead or broken limbs
