We have been at pains throughout to ensure these works are not visible from surrounding areas. So the playhouse is completely hidden by the windowless rear wall of 11a Lyndhurst Road. Likewise the Climbing Wall is completely hidden by the windowless wall of 11b Lyndhurst Rd. And the gazebo at is almost entirely hidden by the surrounding garden walls.

We have left sufficient space between each structure and the neighbouring wall to enable good airflow and allow access . We are very sensitive to the climbing wall, play house and gazebo being less important structures than the surrounding walls and buildings, and will accommodate all reasonable requests for access to the walls behind each structure for maintenance or decoration.
