- a) Remove secondary branches growing downwards from the larger one to increase clearance to about 6m.
- b) Shorten end growth of this branch, and those above where necessary, by up to 2m to clear no.38

2. Smaller branch to the right of the main one, as seen from no.38.

- a) Shorten end growth back to a point vertically above the boundary.

3. Work is confined to growth overhanging the boundary. All work is to be carried out in accordance with BS3998:2010, Recommendations for treework.
