T1 Sweet Chestnut *Castanea sativa* Front Large, veteran tree. Over the last few years, the tree has struggled to flush in spring and has barely produced fruit. Extensive dieback was removed approx. 2 years ago. The upper 2- 3m of the main scaffold limbs have woodpecker holes in them and this is a sign of decay within these limbs. Sweet chestnut is a coppice timber and there is a good chance that a reasonably hard reduction will reinvigorate the tree. The suggested works are: To reduce the overall height by 3 - 3.5m, reduce the lateral spread all round by 2.5 - 3m, remove deadwood.

T2 Cherry *Prunus* spp Rear Mature, previously reduced tree. To maximise the light and to improve the vision of the security cameras, the suggested works are: To reduce the tree back to the previous points of reduction (approx. 1.5 - 2m), thin through the crown by 5%, remove deadwood.
