7. Identification Of Tree(s) And Description Of Works

Reason: Overgrown / Lean / Dangerous

Fell above as close to ground level as reasonably practical, by sectional lopping / dismantling and roping down as necessary, to B.S.3998:21.3.

Drill the cambium layer every 10cm around diameter and supply and insert into stump/s to prevent regrowth, to B.S.3998:21.2 the following:

Ammonium Sulphate Stump Killer.

Species: 1 x Cherry

Position: Front left hand side

Reason: Dying / Dangerous

Fell above leaving 1.5m butt, by sectional lopping / dismantling and roping down as necessary, to B.S.3998:21.3.

Drill the cambium layer every 10cm around diameter and supply and insert into stump/s to prevent regrowth, to B.S.3998:21.2 the following:

Ammonium Sulphate Stump Killer.
