The works are consistent with the Arboricultural Report submitted as part of the previous permission (ref: 2013/7887/P) and the recommendations set out a further Tree Condition Survey carried out by Eight Associates. The report confirms that if we are to keep the tree, it would need to be cut back if it is to have long-term stability. Therefore we are reducing the crown of the tree by 33% in order to preserve the tree.
