Since purchase of the Property in December 1989 until present, the first, second and third floor of the property has been continuously leased out as three self-contained flats, one dwelling on each floor minus access staircase. Since January 2006, Council Tax have been levied on the properties as individual dwellings. The three flats, has been in continuous occupation as three individual dwellings for over 10 years. As a result, the criteria set under the Planning and Compensation Act 1991 is met and therefore we believe that a lawful development certificate should be granted for the property at 164A Clerkenwell Road.
