Camden (Buck Street) Market 192-200 Camden High Street London NW1 8QP

Thank you for your email of 28th June 2017.

We have concerns about the potential relationship between this continued market and the construction of the new Camden Town Station entrance. As you are aware we have been working up proposals for the latter scheme over the past couple of years and are due to seek power via a Transport and Works Act Order in Autumn 2018. In accordance with London Plan policy we would ask that you impose a condition on the permission for the market, assuming you are minded to approve the extension of the temporary period requiring the submission and approval in consultation with TfL of a delivery and servicing plan. We would suggest this plan covers the position whereby access for vehicles to/from the market via Buck Street would be restricted during the station works and instead the routes via Camden High Street and Kentish Town Road would be used and the position without the station works when all accesses can be used.
