Sycamore (T1) - Cavities at sites of old pruning wounds. Previously pruned to give clearance to building. Crown touches building: Prune back from building to give 2m clearance.

Common Lime (T2) - Major deadwood (>50mm) overhanging the playground. Epicormic growth on stem and at base: Remove major deadwood. Remove epicormic growth as part of a regular maintenance schedule.

Common Lime (T4) - Young tree; 6m tall; 120mm stem diameter; 3m crown spread. In fair physiological condition. Stem leans west. Stem is growing through two fences. Crown is overtopped by neighbouring trees: Remove tree to prevent further damage to fences.

London plane (T5) - Cavity and snapped out branch at old pollard points at 7m. Cavity at site of old pruning wound at 4m. Dead limb overhanging neighbouring property: Remove dead limb.

Common Ash (T8) - In poor physiological condition. Previously topped at 8m. Inonotus hispidus fungal fruiting body in crown. Daldinia concentrica fungal fruiting bodies on north of stem at 1m. Decay present within stem: Fell to ground level and grind out stump.

Pissards plum (T10) - Multi stemmed at 1.8m; Previously crown lifted over drive; Cavity in crown at 2m below included branch union: Remove limb above cavity.
