I enclose copies of signatures petitioning the cancellation of the destruction of Rochester Square Temple and any development of the land herewith.



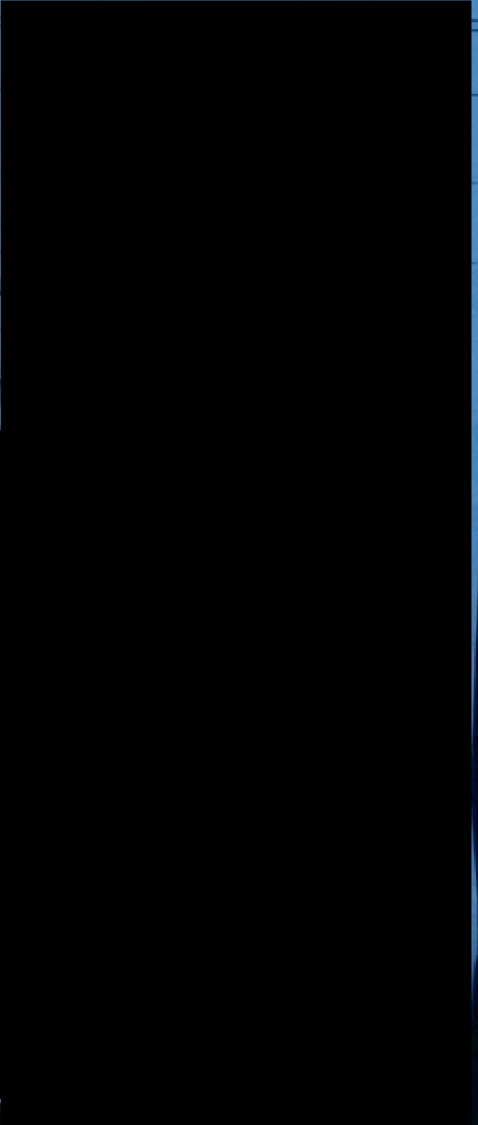
