Although the roof extension will alter the existing roofline, it is very evident from nearby streets (like Willes Road and Ryland Road) that the introduction of roof extensions (even if intermittent) does not in any way detract from the pleasant and unique character and appearance of these streets.
					Roof extensions will not compromise the historical character and appearance of the Inkerman Conservation Area if they are sensitively and consistently designed.
					The ability to build roof extensions helps preserve the existing community by allowing families in the area to extend their houses as their families grow up; without this facility families may be forced to leave the area. In addition, houses with roof extensions allow for more ways that the buildings can be divided up, such has making a 'granny flat' or creating semi-independent space for teenage / student children.
					It could be considered that the application introduces a slope at the rear in line with the Camden Planning Guidance (Design – roofs, terraces and balconies). This way we feel that the pleasant character of the area is maintained, with the strong existing parapet line at the front and the butterfly roof profile at the rear, clearly untouched and dominant.

I believe allowing this and similar schemes would prevent some families moving in search of more space/bedrooms and therefore greatly contribute to the ongoing community spirit in the area. The lines of the original butterfly roof are clearly visible in the design and overall the extension does not detract from the original building design.
