I want to change two windows in the living room from single pan to double glaze. The windows will be changed as follow: Supply and fit two box frame and sashes windows in the main living area. The boxes and subframe will be made in softwood. The sill will be in harwood

The back door will also be changed and refitting with a hard wood - either birch or ash door. It will retain the two window panes and the stained glass window which will be refurbished if possible and if not redone, as per the style.

The door and windows glass will be double glazed 4/16/4 low E toughened argon filled warm edge glass units. Included will be the pulleys, sash, cord, weights, lifts, locks, fitch fasteners sask stops, architrave, extra boards around the windows, bullnose, heavy duty hinges, night lash, dead lock, handles, weather bar. All windows and doors will be preserved, primed, undercoated, 2 finishes. The colour will be white. This work is being done to improve the retention of heat in the house, as well as for added protection.

Included will be a bullnose, heavy duty hinges, dead lock, handles, weather bar. The door will be preserved, primed, undercoated, 2 finishes. It will be white. The original stain glass window will be repaired hopefully, but if this is not possible a new one in the same style and colours will be ordered.
