- T1 Cherry Rear right hand corner This tree has outgrown its space. Fell to ground level and grind down stump approx. 200 mm below ground level
- T2 Sycamore Rear To allow more light through and to contain spread: reduce and reshape by approx. 25% (1-2m), clean out crown
- T3 Sugar Maple Rear To allow more light through and to contain spread: reduce and reshape by approx. 25% (1-2m), clean out crown
- T4 Robinia Rear To allow more light through and to contain spread: reduce and reshape by approx. 25% (1-2m), clean out crown
- T5 Cherry Rear centre Remove poorly pruned secondary stem to ground level. Reduce remaining stem by approx.25 % (1m) to balance and contain.
