Hawthorn tree aprox. 10 meters in height. The tree is totally dead, a tree surgeon has confirmed the tree is dead. It's located in my front garden at 34 West Hill Park, London, N6 6ND. In West Hill Park conservation area. I am not proposing to replace the dead tree as there is an existing equally large Holly tree hard up against the Hawthorn.
