## 7. Grounds for Application

The total increased roof volume will be 27.83m<sup>3</sup> within the 40m<sup>3</sup> of allowed roof volume under permitted development Class B.  
The rear exterior wall of the roof extension will be covered in slate tiles to match the original roof tiles.  
The party wall to the east will be built up in reclaimed London stocks to match the existing with concrete coping stones. The party wall to the west has already been built up by the neighbour when constructing their loft extension.  
The windows will be painted hardwood to match existing.  
The rear dormer wall will be set back from the eaves by 200mm or more.  
The roof extension will be lower than the original roof ridge.
