The application is for an extension in height to the existing terrace balustrades, in order to match the balustrades at neighbouring Flat 1 and to comply with building regulations. A glass extension piece of approximately 200mm is proposed to increase the height of the balustrade to 1100mm above the existing terrace finish floor level. In addition, all terraces are now to be reinstated and the originally proposed enclosures have been removed.

The balustrade extensions and removal of terrace enclosures will be visible on the South, East and West elevations.
