Potential health concerns for residents (especially vulnerable residents in the actual property) and children living in the property plus the adjacent properties and in the local school. Referring to Stewart report recommendations para 6.68 regarding the precautionary approach when sitting this type of equipment near schools, homes of children and vulnerable adults. The location seems unsuitable also as it is in a densely populated area. Our neighbourhood and residents health is already under excessive pressure due to high levels of pollution and the forthcoming massive impact of HS2 and other proposed buildings in the area.</p> <p>There are several balconies on the buildings surrounding the development, some almost at roof level of the proposed development and this would expose them to much greater radiation exposure due to the proximity of the antennas.</p> <p>The number of antennas - 6!! also seems extremely unreasonable.</p> <p>I am very concerned and hope that the fact that this is a council owned property will not bias the decision making process in this instance. Can the interest of residents please be put first for once please, with HS2 coming which will bring with it much pollution, noise and disruption, this neighbourhood is already under a lot of strain. There are already more than 7 masts in the vicinity of this site and the coverage in the area is more than adequate.</p>
