T2 – Large Pear Tree - Reduce height of rear main scaffold limb by approx. 4-5m. The purpose of this is to reduce the weight on the leaning side of the pear tree towards neighbours garden. Balance sides. By reducing the height by this amount it might lead to the sides being reduced considerably to balance the tree.

T3 - Pear - Reduce upward growing branches and shape
