Robinia (T3) - See Sketch Plan TSP-01 Rev 1 Tree Survey Plan

A semi-mature Robinia tree growing within hardstanding to the central courtyard of 77 Parkway. This tree has been subject to past management including topping at 8m and has a canopy formed by the co-dominant regrowth that now over-sails the roofline of the building. We consider that this tree has outgrown its location and is an on-going maintenance issue.

T3 is located centrally within a courtyard building that encloses the tree on all sides with a narrow pedestrian entrance to the north-east. As a consequence of the shape, proximity to and the location of the building which is set-back behind the buildings that front onto Parkway, we believe that the this tree has no public amenity value and that the removal and proposed replacement of this tree will have no impact on the character and appearance of the area.

## 7. Identification Of Tree(s) And Description Of Works

It is proposed that Robinia (T3) is removed and replaced with 1 no. semi-mature Gleditsia Triacanthos (Sunburst Honey Locust) at a height of 5m, with a girth of 20-25cm in the same location.
