1. Weeping Willow (Salix alba 'Tristis'/babyloni Large mature tree. Now dead. Fell to ground level by sectional takedown.
3. Yew Common (Taxus baccata) Very large mature tree. To contain spread and improve clearance over the lawn( and statue). Prune back lateral spread by 1-2m to suitable new growing points, retain maximum greenery. Lift canopy by 1m and level off 'browse line'. Rake out and clear debris and arisings from beneath the tree in this area to tidy.
5. Tulip Tree (Liriodendron tulipifera) Very large mature specimen tree. Main trunk severely damaged and now extensively decayed by apparent lightning strike some years back. To improve condition and maintain it's structural integrity and safety: Clean out crown, remove deadwood, weak and suppressed branches. Thin branch ends by 20-25% to lessen weight, improve air flow and reduce stress on the damaged main trunk. Lift canopy by 1-2m all round and balance crown. Carry out inspection of the main trunk damage area. Report findings.
