Proposal:

(TPO REF C6) WITHIN GRONDS: 1 x Sycamore - Sycamore - Thin throughout the crown by 15-20%, remove small branches (no bigger than 100mm diameter) overhanging the north-east corner of the walled garden

- 1 x Whitebeam Cut the entire tree to ground level
- 1 x Birch Cut the entire tree to ground level
- 1 x Maple Cut the entire tree to ground level
- 4 x Hollies Cut the entire tree to ground level

The Council has considered your application dated 28 July 2017 and decided to grant consent subject to the following condition(s):

Conditions and Reasons:

This decision is valid for 2 years from the date of this decision or until the work is completed, which ever is the sooner.



Reason: To allow the Local planning authority to monitor the completion and standards of the work.

All work shall be carried out in accordance with the relevant recommendations of British Standard 3998: 2010. (Recommendation for Tree Work)

Reason: To ensure the preservation of the amenity value and health of the tree(s).

During the first available planting season following the completion of works, the following trees shall be planted as heavy standards with a girth size of 12-14 cms, unless otherwise agreed in writing by the local authority. The trees shall be planted and maintained to the standards set out in BS8545:2014.

1x Whitebeam (Sorbus aria)

3x Variegated wedding cake tree (Cornus contraversa "Variegata"

1x silver brich (Betula pendula)

Reason: In order to comply with the provisions of Section 206 of the Town and Country Planning Act 1990 (as amended).

Informative(s):

Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife.
