E.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with 1 standard ash in the same place.

Rear Garden:

Large Hornbeam: Approximately 18.00m. Raise crown over lawn area by up to 1.00-1.50m. Assess clearance from building and reduce back from building by 0.50m if required as general maintenance.

Purple Plum / Prunus: Reduce crown by approximately 25% by means of reducing extraneous growth back into main crown structure. Thin crown density by 20% producing a balanced shape of reasonable dimensions for the tree's location.

Robinia Stem (Dead). Approximately 10.00m. This ivy covered stem will become progressively more unstable over time. It would certainly be prudent to reduce to a height of approximately 2.20m. This action will greatly reduce any future hazard potential.

Holly: Adjacent Robinia stem. Approximately 5.00m. Reduce crown by approximately 20% to tidy.

Eucalyptus: Approximately 15.00m. This splendid tree now heavily overhangs the pretty beech and holly beneath. Raise crown over beech and holly by approximately 1.50-2.00m.

Yew: Approximately 5.00m. This tree would benefit from some crown shaping. Judiciously reduce crown by 15%.

7. Identification Of Tree(s) And Description Of Works

Weeping Pear: Willow leaved. Approximately 6.00m. This attractive tree is carrying a significant amount of dead wood. Remove dead wood throughout as is practicable.

Large Conifer / Macrocarpa. Approximately 16.00m. Several broken and hanging branches were noted throughout the crown and hanging over neighbour's property. Dead wood is also present within the crown. Remove dead wood and broken branches.

Sequoia: Approximately 13.00m. This tree is carrying some unattractive dead branches. Remove dead wood as is practicable.

Group of Leyland cypress/woodland walk: Remove dead wood throughout.

Large Juniper: Reduce extraneous branches back into main crown structure to tidy.

Front Garden:

Beech Hedge: Approximately 8.00m. Reduce height back to previous reduction points as general maintenance.

If not otherwise specified then works are as general maintenance and to tidy.
