The Council has considered your application and decided to grant Approval of Details (Listed Building).

Informative(s):

1 Reasons for granting planning permission (approval of details):

This approval of details application of the proposals above, required by condition 3B 2016/4981/L dated 20/02/2017 has been assessed by the council's design and heritage officer and is considered sufficient to appreciate the works involved as it is in keeping with the principles of the overall consented proposal. No harm is caused to the special interest of the grade II* listed building.

The site's planning history was taken into account when coming to this decision.

Special regard has been attached to the desirability of preserving the setting of the listed building and the character and appearance of the conservation area, under s.66 and s.72 of the Listed Buildings and Conservation Areas Act 1990 as amended by the Enterprise and Regulatory Reform Act (ERR) 2013.

As such, the proposal is in general accordance with policy D2 of the emerging London Borough of Camden Local Plan 2017. The proposed development also accords with policy 7.8 of the London Plan 2016 consolidated with amendments since 2011, and paragraphs 14, 17 and 126-141 of the National Planning Policy Framework.

You are advised that condition 3A (Typical details of new gate and alterations to existing railings) relating to Listed Building Consent 2016/4981/L dated 20/02/2017 which needed details to be submitted, has been approved.
