Dear Ms Beaumont

Sir Arthur lectured on his faith to huge audiences throughout this country, in Australia and New Zealand and in America. He was the leading light of Christian Spiritualism (now unfashionable as it mentioned the word Christian and implies morality, ethics, and spiritual values of truth, caring, patience, humility, generosity, peace, etc) that do not feature in SNU 7 short principles.

Conan Doyle was a Theosophist, a Freemason, and likely a member of the Order of the Golden Dawn. He was a knight of the Order of St John of Jerusalem, he was knighted personally by the King of England.

A second facebook campaign to save the historic building from demolition. Nothing is recorded about this church, the stained glass, the mural, the carvings, the measurements and directions. Such neglect by the owners, SNU, a large 340 church property owning charity, now selling off old buildings without concern for heritage. The Conan Doyle Estate should be notified at least! The planning permission was not adequately displayed. Many people have been panicked into action. This is of international interest.
