E.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with 1 standard ash in the same place.

T1 Sycamore x 1 (*Acer pseudoplatanus*) Small specimen, marginally within the size range of a tree protected by a Conservation Area. This specimen is located on the boundary fence and has previously been pollarded. The result is a tree with poor form and very low amenity value. The low crown blocks the secondary canopy of Cherry plum and mixed species. Proposed work: Fell to ground level to improve amenity value of the Cherry plum and prevent damage to the boundary fence. This specimen has no prospect of becoming a mature, feature specimen, hence an alternate planting strategy within the garden has been proposed.

T2 Purple leaf Plum x (*Prunus*) Thin crown by 20% to improve form.

T3 Leyland Cypress x 1 (X Reduce height by 3m and trim sides to £280.00)
Cupressocyparis formal shape.

T4 Fig x 1 (*Ficus carica*) Reduce overhang back to boundary.

T5 Lawsons Cypress x 1 (*Chamaecyparis 'Greyswood Pillar' lawsoniana*) variation, conical specimen which doesn't match the planting profile in this area of the garden. Fell to ground level.

T7 *Prunus* spp x 1 Specimen overhanging T6. Reduce the vertical shoots by 2.5m, attaining a more compact, shaped crown.
