Sycamore T1 - 4m Reduction & remove branches in front of neighbouring windows. Tree is in close proximity to building, therefore works proposed to maintain it at an appropriate size for its location.
Sycamore T2 - Fell, tree has seeded at the base of the wall of the neighbouring block of flats. Fell proposed to avoid any structural damage to building.
Goat Willow T3 - Remove 2 leaning limbs over hanging structure, due to tight unions.
Goat Willow T4 - Multistem Goat Willow, fell due to poor condition (having been severely damaged by machines in the past).
2x Sycamore T5 & T6 - Fell, Self seeded in the top of a retaining wall, proposal to fell due to causing damage to wall & to prevent future issues.
