On behalf of our clients, Mr & Mrs Crocker, please find attached the requested information in order to discharge the conditions as stipulated in the Decision Notice for the above planning application, dated 18 August 2017.

We have submitted the documentation and drawings through the planning portal, that reference is PP-06331537. The condition numbers listed below are as the numbers in the Decision Notice.

- 1) **Condition 3a**) "...manufacturer's specification details of all facing materials and samples of those materials..."
 - a) The facing materials are on site, photos and descriptions of those materials are included in drawings forming this submission, materials include the following:

- 7) There are two remaining pre-commencement conditions, which will be submitted for discharge as soon as they are ready, these include:

 - b) "...appropriate renewable or low carbon sustainable energy sources..."
 - c) "...associated air quality or noise management reports..."

 - "...a contract for the carrying out of the works of redevelopment of the site has been made..."

We trust that this is submission satisfies your requirements and that the conditions listed above can be discharged as the earliest possibility.
