T1 Lime: Reduce canopy by 50%, approx 4-5m beyond previous points of reduction - indication that tree is decayed and hollow in the main stem from tree officer visit, blocking light and damaging wall to mitigate root growth and wind damage or tree failure, very close neighbouring properties who would like the tree lowered in height as it causes excessive shading

T2 Prune to match finished height of T1 - regular maintenance and for aesthetics
