- Thin crown to remove approximately 10% of live branches to improve light and air

penetration through crown. Most thinning cuts will be between 1 and 2 centimetres in diameter. Dismantle the large T4 Mimosa located at the back of property. This tree is leaning over and will be replaced with a new mimosa. Leave stump low.
