The school currently separates all recyclable waste. All classrooms and offices are provided with two clearly marked bins (one for general waste and one for recyclable material). The contents of the recyclable bins are then emptied into the main recycling bins in the external storage area. These bins are collected and emptied by Camden once a week.

As far as the family learning centre is concerned, the same system operates. Once any refurbishment/change of use has been carried out, the school would continue to provide a simple, easily marked system for staff, pupils and visitors to separate waste at the first point of discarding, which would then be deposited in the recycling bins ready for collection.
