T1 Ash x 1 (Fraxinus excelsior) Crown reduce by 3m (to previous points of reduction) to contain the crown and root area to a size suitable for the boundary location.

T2 Tulip Tree x 1 (Liriodendron tulipifera) Reduce by 2m to previous reduction points to contain crown size and root spread. Specimen is in close proximity to the house.

Rear garden

T3 Laurel x 1 (Prunus spp) Neighbour's tree. Reduce to boundary to clear the property.

Front Garden

T4 Cherry x 1 (Prunus spp) Medium sized specimen encroaching upon the neighbouring property. Thin neighbours side by 20% and reduce the crown by 1.5m to contain the spread.

7. Identification Of Tree(s) And Description Of Works

T5 Hawthorn x 1 (Crataegus monogyna) Large hawthorn with decay in the basal area. Reduce crown by 1.5m to previous reduction points to minimise the wind sail and improve form.
