Informative(s):

1 The condition requires the submission of details of acoustic isolation, sound attenuation and anti-vibration measures of any extract ventilating system or plant to safeguard the amenity of the area and adjoining residents. The applicant has provided detailed plans of the location of extract plant together with measures to mitigate their impact to safeguard neighbour amenity. The details provided have been reviewed by the Council's Environmental Health officer and considered sufficient for the approval of condition 30.

The site's planning history and relevant appeal decisions were taken into account when coming to this decision.

The details provided are in general accordance with policies CS5 of the London Borough of Camden Local Development Framework Core Strategy and policies DP26 and DP28 of the London Borough of Camden Local Development Framework Development Policies.
