Dear Mr. Little,

I write to voice my strong objection to the felling of two trees in our garden.

Mr. Camm, in application 2017/5258/T has failed to mention the fact that the oak has a TPO C55 on it. which makes, I believe, the current application is invalid.

In this case the TPO oak is noted on the 1866 Ordinance Survey map as a significant tree then.

It's marked with the symbol for significant trees on the map as a hedgerow tree, the field boundary then, so it is of historical importance.

The tree is in a conservation area and it's an important setting for this Grade 2 Listed House.

The "small" oak Mr. Camm refers to in applications and 2017/5258/T does not exist. This is an attempt to hoodwink the tree officers.

Unfortunately, Mr. Camm has put in applications to remove or to over pollard our tree (resulting in, what I believe is, its current poor health) for the second time now.

In 2013 application 2013-5837-T he put in an application without properly consulting the elderly and infirmed freeholder, Mr. Fathergill.

At the time I sent Camden a letter from Mr. Fathergill refusing to give permission in regard to the oak tree. This should be in Camden's data base. I could not find it nor my objection online today,

The application says it was to reduce the "small oak tree". They removed more than a third of the tree which never should have been done- it was much more

than the application said it would reduce it by. In 2005 dead wood was taken from the tree 2005/4760/T-this application is for the TPO tree.

Please see the chronological list of photographs as proof.

My view and wish is that the tree needs good management and husbandry and to be given a chance after all the abuse that it has suffered.

The oak furthermore, is at the back of a long formal garden, 30 meters from the house and does not, nor has it ever obstructed the light.

As house holders we use the garden because it is so sunny, whilst all the sun loving plants are thriving in the garden also.

It is a danger to no one, there are no targets below or near it.

I suspect that the agent and gardner are looking to clear the garden of its trees to pave the way for rear extension and basement or sell the freehold

with planning for that.

The enclosed photo images from Google Earth demonstrate that neither tree shadows reach the house or

have obstructed light from our very sunny garden.

Regarding the pyracantha- it is not damaging the wall. The wall covers an area extending way beyond the trees roots. The wall has not had basic maintenance

for over 30 years and it is not affecting the building at all. The house is currently undergoing significant restoration and none of the damage is due to trees,

I have lived here for 18 years and have the longest residence and knowledge of the building. It is a beautiful tree and should be thinned

and trimmed back. In my view that would be a very good resolution.

I would be very grateful if Camden would investigate these facts and say no to this inaccurate and dreadful application.

I am writing to you to request you refuse this Notice of Intent where it relates to the TPO'ed oak tree.

This important veteran tree was rather drastically reduced by about 30% in 2011 "to remove major dead wood", to the dismay of those who live at 7 Wedderburn Road. This is a lot of reduction for a veteran oak, though the actual work seems to have been well done. Another 10-15% to be removed this year however is not warranted and puts this significant tree at risk.

As you know, while scrupulous hygiene and good practice when lopping diminish the risk to a tree, it is now not recommended that trees be reduced unless really necessary, particularly veteran trees. Also, dead wood does not all require removal; it is important for biodiversity and should only be removed if it poses a significant risk to more frequently present targets below. From observation of this tree, the dead wood present is very small, is not sited over the lawn but in areas that I understand only the gardener himself would go to. It may even have been precipitated by the recent severe lopping, which could have speeded up retrenchment of this veteran tree; one of the hedgerow oak survivors from the times when this area was farmland.

I have spoken to the Freeholder, an elderly and rather infirm man who lives on the premises and employs a gardener. It would seem this (new) gardener has taken it upon himself to employ a tree surgeon to apply for the work on the oak. The freeholder is not aware of this application, says he does not know of the 'Agent' Nick Camm, and while he agrees with the work on the magnolia and the pittosporum, he is against any work on the oak which has already and recently been very severely lopped.

There are also no evidence papers on Camden website about this application, so I can only presume that this is an incomplete application. Please would you only accept applications and Notices of Intent from 7 Wedderburn Road if the Applicant is mentioned.

Please refuse that part of this Notice of Intent that refers to the TPO'ed oak.


Winter 2006 showing the oak tree's more easterly morning shadow does not reach the house - 30 metres away
