Dear Mr Enirayetan,

I am writing to express my strong objection to the above planning application. The placement of these units should never have been allowed originally and the owners probably got away with it in the days when planning controls were far more lax than they are today. I am an owner of one of the Flats in this building and these air conditioning units are both an eyesore, probably unhealthy and very noisy. I am one of 9 residents who are directly affected by their location as they occupy the entire communal courtyard of the residential area of the building. It is an enclosed central space overlooked by the main entrance doors, balconies and windows of all the flats in the building and therefore an unavoidable eyesore and noise generator. The elevation on all sides of this space is approximately three stories high which considerably amplifies the noise.

I am concerned that, according to the noise assessment document contained in the planning application, the location of the proposed air conditioning units is shown incorrectly. The measurement position is also some distance away from the proposed location and fails to acknowledge that there are 9 flats located much closer, from where no measurements have been taken. The application incorrectly states that the measurement was taken from the nearest noise sensitive window.

I would like the location of the air conditioning units to be reconsidered and would suggest they are located in a different area of the building, preferably in a space available within the confines of the offices which they will service and which would not create the noise and visual pollution which the previous units so badly did and thereby detracted from the quality of life of the residents.
