## **DECISION**

Town and Country Planning Act 1990 (as amended)

Replacement of 2no x crittall windows to the ground floor rear elevation.  
Drawing Nos: 898; 001, 002, 003, 004, Design & Access Statement.

The Council has considered your application and decided to grant permission subject to the following condition(s):

Condition(s) and Reason(s):

- 1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).



- 2 All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy D1 of the London Borough of Camden Local Plan 2017.

- 3 The development hereby permitted shall be carried out in accordance with the following approved plans:

898; 001, 002, 003, 004, Design & Access Statement.

Reason:

For the avoidance of doubt and in the interest of proper planning.

#### Informative(s):

- 1 Reasons for granting permission.

The proposal is to replace two existing Critall single glazed windows on the ground floor rear elevation of one of the flats within Hillsborough Court. The existing windows are in a bad state of repair and are inward opening which do not meet Building Regulations for fire escape. It is proposed to replacement them with new windows and frames using the same design and material. The new crittal windows would be side opening casements in order to meet the requirement for Building Regulations for emergency fire egress. The design, size and appearance would overall be like-for-like.

As such, it is considered to be appropriate in terms of the design, materials, colour, location, opening and frame size. The windows would not be readily visible from public vantage points due to their location at the rear and the fact that they would be set back behind the covered pedestrian walkway. The proposal would not be considered harmful to the character and appearance of the host building and the surrounding area.

Given the minor nature of the proposal, there are no amenity concerns to any adjoining residential occupiers in terms of loss of natural light, outlook, enclosure or privacy.

The site's planning and appeals history has been taken into account when coming to this decision.

Following statutory consultation, no response received to date.

As such, the proposed development is in general accordance with policies A1, D1 of the Camden Local Plan 2017, the London Plan 2016, and the National Planning Policy Framework 2012.

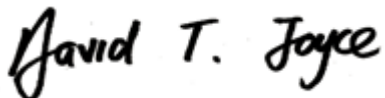
- 2 Your proposals may be subject to control under the Building Regulations and/or the London Buildings Acts that cover aspects including fire and emergency escape, access and facilities for people with disabilities and sound insulation between dwellings. - 3 Noise from demolition and construction works is subject to control under the Control of Pollution Act 1974. You must carry out any building works that can be heard at the boundary of the site only between 08.00 and 18.00 hours Monday to Friday and 08.00 to 13.00 on Saturday and not at all on Sundays and Public Holidays. You are advised to consult the Council's Noise and Licensing Enforcement Team, Camden Town Hall, Judd St, Kings Cross, London NW1 2QS (Tel. No. 020 7974 4444 or search for 'environmental health' on the Camden website or seek prior approval under Section 61 of the Act if you anticipate any difficulty in carrying out construction other than within the hours stated above.

In dealing with the application, the Council has sought to work with the applicant in a positive and proactive way in accordance with paragraphs 186 and 187 of the National Planning Policy Framework.
