ENFORCEMENT NOTICE

ISSUED BY: THE LONDON BOROUGH OF CAMDEN

1. **THIS IS A FORMAL NOTICE** which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.

2. **THE LAND TO WHICH THE NOTICE RELATES**

Land at: 47 Great Russell Street, London, WC1B 3PB as shown outlined in black on the attached plan (“the Property”).

3. **THE BREACH OF PLANNING CONTROL ALLEGED**

Without planning permission: The unauthorised change of use of the front two rooms at ground floor level from Class A1 retail to Class C3 residential accommodation

4. **REASONS FOR ISSUING THIS NOTICE:**

1. *It appears that the breach of planning control has occurred within the last 4 years.*
2. *The change of use of the front two rooms of the ground floor from Class A1 retail use to Class C3 residential accommodation, by reason of the loss of a retail unit within a designated frontage, harms the character, function, viability and vibrancy of the specialist shopping area of Museum Street. This is contrary to policy TC2 (Protecting and enhancing Camden's centres and other shopping areas) of the London Borough of Camden Local Plan.*

Council reference: EN16/0452

The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.

5. **WHAT YOU ARE REQUIRED TO DO**


Within a period of **three months** of the Notice taking effect:

- 1) *Permanently cease the use as residential accommodation.*

6. **WHEN THIS NOTICE TAKES EFFECT**

This notice takes effect on **22nd November 2017** unless an appeal is made against it beforehand.

Note Pursuant to Regulation 5 of the Town and Country (Enforcement Notices and Appeals) (England) Regulations 2002

If you appeal against the notice on Ground (a) "That planning permission should be granted for what is alleged in the enforcement notice, or that the condition which is alleged not to have been complied with should be discharged" there is a fee payable under Regulation 10 of the Town and Country Planning (Fees for Applications, Deemed Applications, Requests and Site Visits) (England) Regulations 2012/No.2920 for the deemed application for the planning permission for the development alleged to be in breach of planning control in the enforcement notice.
