I wish to change a rear PVC window to a traditional timber sash window.

At the rear of the property (shown on the elevation plans) there are currently two windows. On the left is a timber sash window, which is a '2 on 2' in the original period style of the property. On the right is a small, modern PVC window, which is not in keeping with the style of this or adjacent properties, and is not in the original position of the window.

I propose to remove the PVC window, and replace it with a timber sash window, built to match the existing sash window exactly. The new window will be slightly larger, and slightly to the left of the old PVC window, in order to align better with the other original windows in the building. (There will continue to be a PVC window on the right hand side of the flat above, which is also not in the original position).

The end result, as the elevation plans show, will be two aligned timber sash windows in the original style of the property.
