Tulip Tree - removal, due to risk to public of falling branches..

The tulip tree located within the garden at the junction of St Giles Passage/New Compton Street is thirty years old and is slowly failing. Planted above rubble-filled cellars (the garden is a former bombsite) it is now showing its unsuitability in the long term for the conditions at this location; the crown is uncharacteristically thin, the foliage is always severely chlorotic and it is dropping branches, with increasing frequency and without warning, into the garden and onto the adjacent pavement - increasingly large limbs are being shed, with the last to drop being 3m+ and 10cm girth.

Due to the risk to garden visitors and the general public, and the unsuitability of site for the success of the tree in the long term, we are looking to remove the tree to ground level.

We would not look to plant a replacement tree in this position. Growing adjacent to the tulip tree is a Ginkgo biloba, this has been shaded by the tulip tree and has grown in an uncharacteristic form and we would look for this, with the reduction of competition, to be able to grow out properly.
